TWELVE RESIDENTIAL GROUP HOMES OPERATE FOR YOUNG PEOPLE WHO HAVE BEEN ABUSED, ABANDONED OR NEGLECTED. APPROXIMATELY 98% OF KING'S HOME YOUTH HAVE BEEN ABUSED, 75% ARE CLASSIFIED WITH SEVERE BEHAVIORAL PROBLEMS AND 90% ARRIVE AT LEAST ONE YEAR BEHIND IN SCHOOL. KING'S HOME MODELS EFFECTIVE AND POSITIVE FAMILY LIFE FOR TROUBLED YOUTH IN A STRUCTURED, GOAL ORIENTED, HOME STYLE ENVIRONMENT. YOUNG PEOPLE ACQUIRE SOCIAL SKILLS WHILE BEING ENCOURAGED TO TAKE RESPONSIBILITY FOR THEMSELVES AND FOR EACH OTHER. TANGIBLE SERVICES TO ASSIST YOUTH INCLUDE SOCIAL SKILLS, EDUCATION, JOB SKILLS TRAINING AND/OR FURTHERING EDUCATION PREPARATION AND AID,
